RVC Column for Region 10

The agenda for the American Mensa Committee (AMC) meeting for April 1 has been posted at <u>us.mensa.org/lead/amc/meeting-reports/</u> and it is a busy one.

The biggest part of the agenda comes from the Finance Committee, and is divided into several motions. First is a motion to change the single-year dues rate to \$79.00. This is based on a number of factors, including but not limited to the long-delayed expense of replacing an antiquated computer system, a desire to provide more support to local groups, general inflation, and debt building up after deferred dues increase requests from prior years. Next is a motion to appoint an auditor for the AML financial statements, which is a routine matter. Third is a motion to waive the current requirement for equity restoration for one year based on the projected budget shortfall for next year. The equity restoration is based on the commitment of prior AMCs to pay back the legal expenses from a lawsuit a few years ago, and this motion is intended to defer that just for one year. The fourth Finance motion is a change in the way dues payments are processed, including pro-rated dues for new and returning lapsed members, which could not be implemented until the recent upgrade of the AMS (Association Management System). The fifth motion is a request to increase the Testing and Prior Evidence Review fees, which were last changed ten years ago. Test supply costs and payments to local groups have increased over the years, and this is a catch-up measure. Finally, the last Finance Committee motion is to approve the Fiscal Year 2017-2018 budget, which is predicated by the previous motions.

There are also several Local Group related motions. These include revisions in the Minimum Standard Bylaws and Model Bylaws, to bring them in line with ASIEs (Actions Still In Effect) passed over the past few AMC sessions; procedures to standardize the dissolution of Local Groups that are not meeting the minimum requirements of their charter; and a revision of the Information and Privacy Policy to bring it into alignment with actual current practices.

Reports to the AMC will include a presentation of the results of the recent Membership Satisfaction survey, and an update from the Awards Review Task Force.

There is time set aside at the beginning and end of every AMC meeting for comments from the audience, and all members are welcome to attend. Since this is being held in our Region, I hope some of you will attend to offer your perspectives and see the AMC in action. The meeting will be on Saturday, April 1 at the Diplomat Beach Resort (which is also the site of the Annual Gathering in July), beginning at 9:00 am. The Diplomat is located at 3555 South Ocean Drive, Hollywood, Florida.

First Vice Chair

Members and local groups count. Or do we? Mensa has turned away from members and local groups and become a highly-centralized corporate behemoth. I want to turn Mensa back toward us.

The AMC should listen more, govern less, and cut costs instead of raising dues. This could also provide more funds and support for local groups. I favor more transparency and fewer executive sessions. AGs should be returned to local groups.

The national office performs numerous expensive activities that volunteers can do as well for free, discouraging member involvement and stifling creativity. National should instead use members' expertise; provide usable tools and reports to local officers; and help local groups enhance members' experience, thus increasing retention rates. The office



should ask us what we need or want, not give us what they think we should have. The new "improved" website shows what can go wrong when we are ignored. The executive director should be evaluated on how well the office serves current members.

During six years as National Ombudsman, I listened carefully to members' concerns and helped resolve problems, often defusing disputes before positions became hardened. I will put these same skills to work for you as First Vice Chair. Understanding and truly considering differing viewpoints will help rid Mensa of the "us vs. them" mentality. After being a Mensa member for more than 40 years, serving with four different AMCs, I know how the AMC works—and how it sometimes doesn't.

An attorney admitted to practice before the U.S. Supreme Court, I also am a Wharton economics graduate. I have served as a diplomat in Afghanistan and Mexico, treaty negotiator, Congressional staffer, General Counsel for the U.S. Commission on International Religious Freedom, and chief editor for the Secretary of HUD. On This Month in History: April

On April 12, 1961, Yuri Gagarin, a Soviet cosmonaut, became the first man in space. He completed a single orbit around the Earth in a four-and-a-half ton *Vostok 1* spacecraft. The flight lasted approximately 108 minutes. His flight intensified the Space Race between the Soviet Union and the United States—Alan Shepard would not make it as the first American in space until later that year, in May.

Birthdays in this month include Harry Houdini on April 6, 1874, and Mary Wollstonecraft on April 27, 1759. Houdini was an American escape artist and magician, gaining fame from repeatedly escaping from police handcuffs and jails. Wollstonecraft was an English writer and feminist noted for *A Vindication of the Rights of Women*, which demanded equal rights in education.
